## COURSE OVERVIEW

This four-day class brings entirely new investigative concepts and best practices to law enforcement, highlighting early data investigations to the volume of evidence faced today. The evidence validation standards presented in this class are a new discipline and methodology designed to meet evolving laws, policies and rules surrounding digital evidence.
